3. There is no power available to market stalls at this site.
4. Insurance for loss, damage and public liability is the responsibility of the stallholder. The Gladstone Festivals & Events Association Inc. (referred to as GF&E) will not be responsible for any loss or damage incurred by stalls or contents, or for damage caused by stallholders, their equipment or vehicles, to property owned by either stallholders or contractors.

The GF&E reserves the right to expel any stallholder and requires such stallholder to be removed should the conduct of the stallholder be in any way detrimental to the well-being of the Festival, or should the products/services be other than those stated in this agreement. In the case of such expulsion, monies paid to the GF&E will not be refundable.
